RESPONSE (b. – g.): The actual cost of responding to this request would require a search to be conducted by the City of Marshalltown IT-contractor. It takes approximately 15 minutes to search 1 account for 1 month of email for a particular keyword. The hourly cost would be \$120 per hour. The City currently has 184 email accounts. The request is for 2 keywords and 4 outside email addresses. The estimate would be 184 accounts X 6 keywords = 1,104 quarter hours or 276 total hours per month searched. For 12 months, that would be 3,312 hours of labor at \$120 per hour, totaling \$397,440.00. Furthermore, all non-routine such as this require attorney review for legally protected confidential information which would have costs at \$200 per hour. Payment for this search would be required in advance.

Enclosures (17.) through (25.) provide evidence of honorably and ethically performed government body public record searches utilizing modern commercial information system data storage solutions. Enclosures (18.), (19.), and (20.) provide evidence of acceptable levels of deviation in light of government body articulated and detailed communications of specific government body variables.

5. The Form of the Iowa Public Information Board

The form of the Iowa Public Information Board is displayed by the evidence that shows that upon receipt of evidence showing Iowa government body behavior against an Iowa public records requester consistent with the requirements of [Iowa Code Section 708.7\(1\)\(a\)\(4\)](#) the Iowa Public Information Board did nothing to protect the rights of citizens. On the contrary, the Iowa Public Information Board utilized tax dollars to produce a proposed addition to Iowa Code Chapter 23, allowing it to terminate citizens' rights to request public records *"for a specified period of time, but not to exceed one year,"* (**See:** Proposed [Iowa Code Section 23.8A\(f\)](#)) At the same time, the Iowa Public Information Board spread a false criminal allegation supported by zero evidence against that public records requester (**See:** Enclosures (1.), (2.) and (3.) to fuel and justify this proposed legislation while protecting government bodies from accountability regarding evidence of their abuse of power and hostility toward an Iowa public records requester regarding requested public records evidence indicates these government bodies desired not to release (**Note:** [Section 9 of Article 1 of the Constitution of the State of Iowa](#) states: *"Right of trial by jury—due process of*

law. The right of trial by jury shall remain inviolate; but the general assembly may authorize trial by a jury of a less number than twelve men in inferior courts; but no person shall be deprived of life, liberty, or property, without due process of law.”)

Ultimately, this behavior manifested by the Iowa Public Information Board is the responsibility of Iowa Governor Kim Reynolds and the Iowa Legislature as articulated in [Iowa Code Sections 23.3\(1.\)](#).

*“An Iowa public information board is created consisting of nine members appointed by the governor, subject to confirmation by the senate. No more than three members appointed shall be representatives from the media including newspapers and no more than three members appointed shall be representatives of cities, counties, and other political subdivisions of the state.”*Iowa Code Title I State Sovereignty and Management, Chapter 23 Public Access to Government Information (Iowa Public Information Board Act) – Section 23.3(1.) – Board appointed —executive director.

Evidence showing that Iowa Public Information Board Executive Director Erika Eckley’s actions, selection, and continued appointment are the responsibility of the Iowa Public Information Board is shown in [Iowa Code Section 23.3\(6.\)](#).

*“The board shall select one of its members to serve as chairperson and shall employ a person who shall be an attorney admitted to practice law before the courts of this state to serve as the executive director of the board.”*Iowa Code Title I State Sovereignty and Management, Chapter 23 Public Access to Government Information (Iowa Public Information Board Act) – Section 23.3(6.) – Board appointed —executive director.
